Today, Noticias Uno learned that the Judge in charge of the proceeding will call Rafael Garcia to testify, former Head of Information Technology of the DAS, who reported through this document that there was in fact a set-up that had been orchestrated through Jorge Noguera with the support of the Secret Unit of the DAS called SIU, Group of Sensitive Operations. But Mr. Noguera replied that the Presidency had ordered him to involve Llanos Oil and Servicios Petroleros del Caribe and its executives in an investigation that would implicate them in illegal activities.</p>
