At the request of the company incorporated under the law of the Isle of Man called LLANOS OIL EXPLORATION LTD., having its principal place of business in Bogotá D.C., (Republic of Colombia), hereby choosing domicile in Amsterdam at Maassluisstraat 258, at the office of process servers M.C. Groot and J.S. Evers;

Amsterdam and having its principal place of

the corporation ABN AMRO BANK N.V., having its registered office and principal place of business in Amsterdam, at Gustav Mahlerlaan 10, serving my summons at this office address, speaking to and leaving a copy of this document, as well as of the petition with judgment to be referred to below, as well as the form in duplicate as referred to in Art. 475, Subsection 2 of the Code of Civil Procedure with:

employed at said office:

a petition with which my Petitioner applied to the summary trial judge at the Court at The Hague, including the bailiff's copy of the judgment rendered on November 19, 2009 by His Honor, regarding the permission to have prejudgment garnishment levied as referred to below;

Subsequently, I, the process server, operating as indicated above, by virtue of the aforementioned judgment against the garnishee mentioned above

GARNISHED BEFORE JUDGMENT:

all moneys, monetary values, and/or movable property which are not registered property, which the garnishee has under them and/or will or may obtain under an already existing legal relationship, or has already in their custody under an already existing legal relationship and/or may obtain, owes or will owe to ECOPETROL S.A., a company incorporated under the law of Colombia, having its principal place of business in Bogotá D.C., Republic of Colombia, at Carrera 7 no. 37-65, as a security for and to obtain the payment of an amount of €7,000,000,000.00 (seven billion Euros), at which amount Petitioner's claim described in the above mentioned claim against the aforementioned judgment debtor is provisionally estimated by means of the aforementioned judgment hereby served, including interest and expenses, and for which claim the claim in principal action will be brought by Petitioner within 6 months after the first prejudgment garnishment levied to that effect;

ORDERING:

to the garnishee to retain possession of the moneys owed or the property, on pain of vitiation of any payment or surrender made in contravention of the garnishee order.

The costs incurred are €150.49 including an increase according to article 10 of the decree on fees for process servers exercising their duty.
